## CONSTRUCTION OF 11 NO BOREHOLES IN MURANG'A COUNTY TENDER NO: MWS/UTaNRMP/TEN/003/2019/2020

Following the Pre-tender site meeting held at the dam site on 6<sup>th</sup> and 7<sup>th</sup> February 2020, the following are the amendments and addendum to the tender document:

### 

- 1. Prospective bidders note that the BoQs did not provide for the mobilization/demobilization and setting up for each of the bills;
- 2. The meeting noted that the cable sizing of 4Kw with a pump of 5.5kW. They should be the same (for Saba Saba, secondary, Maganjo, mwangaza, St. Teresa secondary school), it was also recommended that the hammered cable used should be thicker to minimize the voltage drop due to the long distance from the power source. There is need for streamlining the Pump motor and control panel in most of the BoQs.
- 3. There was need to clarify on the size and type of controller panels to be used for the boreholes;
- 4. Who will be responsible for making Sabasaba Borehole site accessible?
- 5. It was noted that trenching was not factored in the BoQ for cable connection and pipe connection between the power source and water tower respectively from the borehole location. This needed to be clarified.
- 6. There was no figure given under the supervision fee; it is stated as a lump sum.
- 7. There is No provision for contingencies in BoQ.
- 8. The extent of plumbing works to be provided and who will be responsible.
- 9. It was noted that item 18, that the submersible cable is thin at 4mm square





# RESPONSE TO ISSUES RAISED DURING PRE-TENDER SITE VISIT ON $6^{TH}$ AND $7^{TH}$ FEBRUARY 2020

- 1) Where not indicated mobilization and demobilization should be included in the bill of quantities as indicated below:-
- 2) Item 14:- Supervision fee has a pre-determined amount of KShs. 300,000.
- 3) Item16:- All controller panels for 11No boreholes to be hybrid, 5.5KW.
- 4) Plumbing work will be up to the water tower, the schools to shoulder the cost of supplying water to the various points as need be.
- 5) Trenching costs should be included in the Installation of cables
- 6) The school head(s) to ensure the site is accessible.
- 7) Item25:- The cable size should be carry the same power has the pump. 5.5 KW
- 8) 1tem 18:-should read 'supply and still 6 mm sq. Submersible cable'.

### OTHER ISSUES RAISED BY A BIDDER

- 1. St. Theresa Sec School: Armoured cable from BH to pump controller is missing
- 2. Kirwara High School Pv disconnect should be 1000v/40A not 440v/40A. Total Armored cable should be atleast 6mm2.
- 3. Mwangaza Sec. School. Armoured cable from BH to pump controller is missing
- 4. Muunguni Maendeleo Ya Wanawake Self Help Group:- More details and clarification to be done on fencing since 120 Number posts cannot be fenced by 4rolls of chain link.

#### UTanrmp response to other issues raised by a bidder:

- 1. St. Theresa Sec School:- One Hundred Fifty (150) metres 6mmsq armoured cable from BH to pump controller
- 2. Kirwara High School: Pv disconnect should be 1000v/40A not 440v/40A.
- 3. Mwangaza Sec School: Twenty five (25) metres 6mmsq armoured cable from BH to pump controller
- 4. Muunguni Maendeleo Ya Wanawake Self Help Group:- More details and clarification to be done on fencing since 120 Number posts cannot be fenced by 4rolls of chain link.
